**Philosophy:** We believe the market provides opportunities to invest in individual companies that are trading at a discount to their intrinsic value. We act independent of Wall Street, focusing on valuation, and invest for the long-term.

**Objective:** Long-term capital appreciation

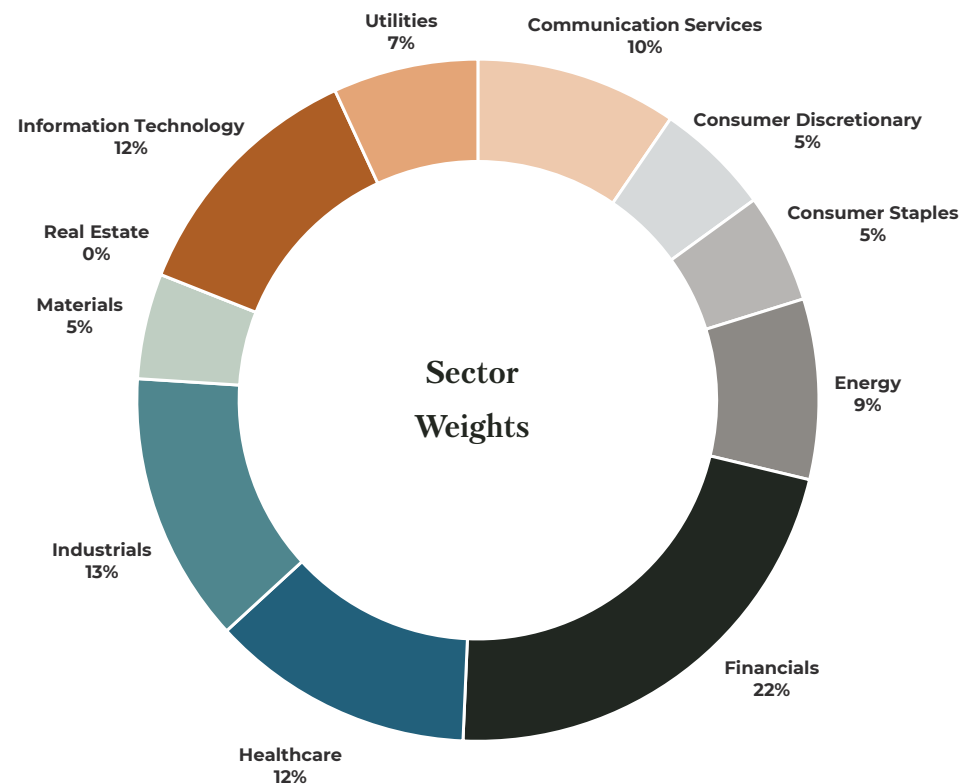
**Framework:**

- Primarily invests in stocks with market capitalizations >\$10 billion
- Fund typically holds 45-60 stocks
- Initial position sizes range from 1-2%; maximum position size of 5%
- Maximum sector exposure 35% (typically +/- 10 percentage points of benchmark weighting)

<sup>3</sup>**P/E** is a valuation ratio of a company's current share price compared to its per-share earnings. **PRICE/BOOK** is a valuation ratio of a company's current share price compared to its per-share book value. **MARKET CAPITALIZATION** is the market price of an entire company, calculated by multiplying the number of shares outstanding by the price per share.
